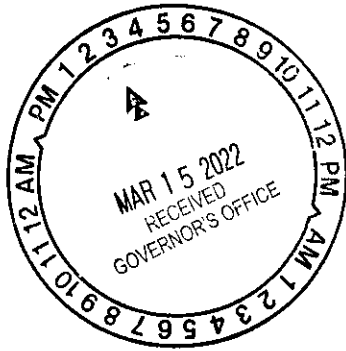

4 ENROLLED, An Act,

5 To make an appropriation of \$169,633 from the State  
6 General Fund to the Coalition Against Domestic Violence for  
7 the fiscal year ending September 30, 2023, to require an  
8 operations plan and an audited financial statement prior to  
9 the release of any funds, and to require quarterly and end of  
10 year performance reports.

11 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

12 Section 1. For the fiscal year ending September 30,  
13 2023, there is hereby appropriated to the Coalition Against  
14 Domestic Violence from the State General Fund the sum of  
15 \$169,633. In addition, the appropriation made herein shall be  
16 budgeted and allotted pursuant to the Budget Management Act  
17 and Article 4 of Title 41 of the Code of Alabama, 1975, and  
18 specifically Section 41-4-93, Section 41-4-95 and Section  
19 41-4-96.

20 Section 2. Prior to the release of any funds  
21 appropriated under this bill for fiscal year 2023, an  
22 operations plan for fiscal year 2023 and an audited financial  
23 statement for all operations during fiscal year 2021 must be  
24 forwarded to the Director of Finance. It is the intent to


1 release fiscal year 2023 funds following receipt of these reports.

2 Section 3. In addition, quarterly reports for fiscal  
3 year 2023 shall be made to the Director of Finance relating to  
4 planned expenditures and accomplishments. An end of year  
5 performance report for the fiscal year 2023 shall be made to  
6 the Director of Finance stating the work accomplished and  
7 services provided and the costs of accomplishing the work and  
8 providing the services, citing meaningful measures of program  
9 effectiveness and costs, as is required for state agencies in  
10 Code of Alabama 1975, Section 41-19-11. The Director of  
11 Finance shall forward a copy of all required reports to the  
12 Legislative Council in a timely manner.

13 Section 4. This act shall become effective October  
14 1, 2022.
