1 Enrolled, An Act,

To make an appropriation of \$389,327 from the Education

- 5 Trust Fund to Southern Preparatory Academy, formerly Lyman
- 6 Ward Military Academy, in Camp Hill, Alabama for the support
- 7 and maintenance of the educational program of the institution,
- 8 for the fiscal year ending September 30, 2024; to provide that
- 9 the appropriation is subject to certain provisions of the Code
- of Alabama 1975; to require an operations plan and an audited
- 11 financial statement prior to the release of any funds; and to
- 12 require an end of year report.
- 13 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
- Section 1. There is hereby appropriated the sum of
- 15 \$389,327 from the Education Trust Fund to Southern Preparatory
- 16 Academy, formerly Lyman Ward Military Academy, in Camp Hill,
- 17 Alabama for the support and maintenance of the educational
- 18 program of the institution, for the fiscal year ending
- 19 September 30, 2024.
- Section 2. The above appropriation is made for the
- 21 support of public education in Alabama and for the support and
- 22 maintenance of the above program. The appropriation shall be
- 23 subject to the provisions, terms, conditions, and limitations
- of the Budget and Financial Control Act, Code of Alabama 1975,
- 25 Section 41-4-80 et seq.; the provisions of the Budget
- 26 Management Act of 1976, Code of Alabama 1975, Sections 41-19-1
- 27 et seq.; and any other provisions of this act.
- Section 3. (a) Prior to the release of any funds

- 29 appropriated under this act, the following reports shall be
- 30 submitted:
- 31 (1) An operations plan for the fiscal year 2024,
- 32 including goals and measurable performance indicators, shall
- 33 be submitted to and approved by the Director of Finance, as
- 34 provided for state agencies in Code of Alabama 1975, Section
- 35 41-19-10.
- 36 (2) An audited financial statement for all operations
- 37 during the fiscal year 2022.
- 38 (b) It is the intent that funds appropriated for fiscal
- 39 year 2024 shall be released by the Director of Finance
- 40 following receipt of the above reports.
- 41 (c) In addition, quarterly reports shall be made to the
- 42 Director of Finance relating actual expenditures and
- 43 accomplishments to planned expenditures and accomplishments.
- 44 An end of year performance report for the fiscal year 2024
- 45 shall be made to the Director of Finance stating the work
- 46 accomplished and the services provided and the costs of
- 47 accomplishing the work and providing the services, citing
- 48 meaningful measures of program effectiveness and costs, as is
- 49 required for state agencies in Code of Alabama 1975, Section
- 50 41-19-11.
- 51 (d) The Director of Finance shall forward a copy of all
- 52 required reports to the Legislative Council in a timely
- 53 manner.
- Section 4. This act shall become effective October 1,
- 55 2023.
