1 Enrolled, An Act,

4 To make an appropriation of \$1,069,234 from the
5 Education Trust Fund to Talladega College in Talladega,
6 Alabama for the support and maintenance of the educational
7 program of the institution, for the fiscal year ending
8 September 30, 2024; to provide that the appropriation is
9 subject to certain provisions of the Code of Alabama 1975; to
10 require an operations plan and an audited financial statement
11 prior to the release of any funds; and to require an end of
12 year report.

13 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

14 Section 1. There is hereby appropriated the sum of
15 \$1,069,234 from the Education Trust Fund to Talladega College
16 in Talladega, Alabama for the support and maintenance of the
17 educational program of the institution, for the fiscal year
18 ending September 30, 2024.

19 Section 2. The above appropriation is made for the
20 support of public education in Alabama and for the support and
21 maintenance of the above program. The appropriation shall be
22 subject to the provisions, terms, conditions, and limitations
23 of the Budget and Financial Control Act, Code of Alabama 1975,
24 Sections 41-4-80 et seq.; the provisions of the Budget
25 Management Act of 1976, Code of Alabama 1975, Sections 41-19-1
26 et seq.; and any other provisions of this act.

27 Section 3. (a) Prior to the release of any funds
28 appropriated under this act the following reports shall be

29 submitted:

30 (1) An operations plan for the fiscal year 2024,
31 including goals and measurable performance indicators, shall
32 be submitted to and approved by the Director of Finance, as
33 provided for state agencies in Code of Alabama 1975, Section
34 41-19-10.

35 (2) An audited financial statement for all operations
36 during the fiscal year 2022.

37 (b) It is the intent that funds appropriated for fiscal
38 year 2024 shall be released by the Director of Finance
39 following receipt of the above reports.

40 (c) In addition, quarterly reports shall be made to the
41 Director of Finance relating actual expenditures and
42 accomplishments to planned expenditures and accomplishments.
43 An end of year performance report for the fiscal year 2024
44 shall be made to the Director of Finance stating the work
45 accomplished and the services provided and the costs of
46 accomplishing the work and providing the services, citing
47 meaningful measures of program effectiveness and costs, as is
48 required for state agencies in Code of Alabama 1975, Section
49 41-19-11.

50 (d) The Director of Finance shall forward a copy of all
51 required reports to the Legislative Council in a timely
52 manner.

53 Section 4. This act shall become effective October 1,
54 2023.
