- 1 Enrolled, An Act,
- 2 To make an appropriation of \$408,793 from the Education
- 3 Trust Fund to Southern Preparatory Academy in Camp Hill,
- 4 Alabama for the support and maintenance of the educational
- 5 program of the institution, for the fiscal year ending
- 6 September 30, 2025; to provide that the appropriation is
- 7 subject to certain provisions of the Code of Alabama 1975; to
- 8 require an operations plan and an audited financial statement
- 9 prior to the release of any funds; and to require an end of
- 10 year report.
- 11 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
- 12 Section 1. There is hereby appropriated the sum of
- 13 \$408,793 from the Education Trust Fund to Southern Preparatory
- 14 Academy in Camp Hill, Alabama for the support and maintenance
- of the educational program of the institution, for the fiscal
- year ending September 30, 2025.
- 17 Section 2. The above appropriation is made for the
- 18 support of public education in Alabama and for the support and
- 19 maintenance of the above program. The appropriation shall be
- 20 subject to the provisions, terms, conditions, and limitations
- of the Budget and Financial Control Act, Code of Alabama 1975,
- 22 Section 41-4-80 et seq.; the provisions of the Budget
- 23 Management Act of 1976, Code of Alabama 1975, Sections 41-19-1
- 24 et seq.; and any other provisions of this act.
- Section 3. (a) Prior to the release of any funds
- 26 appropriated under this act, the following reports shall be
- 27 submitted:
- 28 (1) An operations plan for the fiscal year 2025,

- 29 including goals and measurable performance indicators, shall
- 30 be submitted to and approved by the Director of Finance, as
- 31 provided for state agencies in Code of Alabama 1975, Section
- 32 41-19-10.
- 33 (2) An audited financial statement for all operations
- 34 during the fiscal year 2023.
- 35 (b) It is the intent that funds appropriated for fiscal
- 36 year 2025 shall be released by the Director of Finance
- 37 following receipt of the above reports.
- 38 (c) In addition, quarterly reports shall be made to the
- 39 Director of Finance relating actual expenditures and
- 40 accomplishments to planned expenditures and accomplishments.
- 41 An end of year performance report for the fiscal year 2025
- 42 shall be made to the Director of Finance stating the work
- 43 accomplished and the services provided and the costs of
- 44 accomplishing the work and providing the services, citing
- 45 meaningful measures of program effectiveness and costs, as is
- 46 required for state agencies in Code of Alabama 1975, Section
- 47 41-19-11.
- (d) The Director of Finance shall forward a copy of all
- 49 required reports to the Legislative Council in a timely
- 50 manner.
- 51 Section 4. This act shall become effective October 1,
- 52 2024.
