HB149 Enrolled

1 Enrolled, An Act,

2 To make an appropriation of \$1,176,157 from the
3 Education Trust Fund to Talladega College in Talladega,
4 Alabama for the support and maintenance of the educational
5 program of the institution, for the fiscal year ending
6 September 30, 2025; to provide that the appropriation is
7 subject to certain provisions of the Code of Alabama 1975; to
8 require an operations plan and an audited financial statement
9 prior to the release of any funds; and to require an end of
10 year report.

11 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

12 Section 1. There is hereby appropriated the sum of
13 \$1,176,157 from the Education Trust Fund to Talladega College
14 in Talladega, Alabama for the support and maintenance of the
15 educational program of the institution, for the fiscal year
16 ending September 30, 2025.

17 Section 2. The above appropriation is made for the
18 support of public education in Alabama and for the support and
19 maintenance of the above program. The appropriation shall be
20 subject to the provisions, terms, conditions, and limitations
21 of the Budget and Financial Control Act, Code of Alabama 1975,
22 Sections 41-4-80 et seq.; the provisions of the Budget
23 Management Act of 1976, Code of Alabama 1975, Sections 41-19-1
24 et seq.; and any other provisions of this act.

25 Section 3. (a) Prior to the release of any funds
26 appropriated under this act the following reports shall be
27 submitted:

28 (1) An operations plan for the fiscal year 2025,

29 including goals and measurable performance indicators, shall
30 be submitted to and approved by the Director of Finance, as
31 provided for state agencies in Code of Alabama 1975, Section
32 41-19-10.

33 (2) An audited financial statement for all operations
34 during the fiscal year 2023.

35 (b) It is the intent that funds appropriated for fiscal
36 year 2025 shall be released by the Director of Finance
37 following receipt of the above reports.

38 (c) In addition, quarterly reports shall be made to the
39 Director of Finance relating actual expenditures and
40 accomplishments to planned expenditures and accomplishments.
41 An end of year performance report for the fiscal year 2025
42 shall be made to the Director of Finance stating the work
43 accomplished and the services provided and the costs of
44 accomplishing the work and providing the services, citing
45 meaningful measures of program effectiveness and costs, as is
46 required for state agencies in Code of Alabama 1975, Section
47 41-19-11.


48 (d) The Director of Finance shall forward a copy of all
49 required reports to the Legislative Council in a timely
50 manner.

51 Section 4. This act shall become effective October 1,
52 2024.


