## Parking Space Acknowledgement & Agreement Form

The Alabama State Legislature, by and through the Legislative Parking Committee, at its discretion assigns the use of parking spaces under its authority and control to legislative employees and officials, as well as to other public officials and employees of state government as available space provides. The provision of parking spaces to assignees is free of charge at this time. In exchange for the assignment, access, and use of the above-referenced parking space, or any other parking space under the authority and control of the Legislature or the Legislative Parking Committee, the above-referenced and undersigned party to this Parking Space Acknowledgement & Agreement Form ("this Form") hereby acknowledges and agrees to the following (provisions, terms, understandings, responsibilities, and conditions):

- The undersigned party acknowledges, agrees, and understands that the following terms have the following meanings under this Form: The term "the Committee" refers to the Legislative Parking Committee, and includes any and all members and employees thereof. The term "Legislature" refers to the Alabama State Legislature, and includes any and all members and employees thereof. The term "parking space" means, unless referenced otherwise, a parking space under the authority and control of the Legislature and the Legislative Parking Committee, and includes the parking lot (or street?), if applicable, in which the assigned parking space is located.
- The undersigned party acknowledges, agrees, and understands that the Legislature, by and through the Committee, is providing access and use to the parking space described above at no cost to the undersigned party, and in its sole discretion may revoke or modify the access or use of this assigned parking space, or any other parking space at any time, with or without advanced notice.
- The undersigned party acknowledges, agrees, and understands that any access and use of the assigned parking space, or any other parking space is at his or her own risk, and that the Legislature and the Committee owe no duty to the undersigned party to warn of any dangers or potential dangers, other than hidden dangers that would not otherwise be revealed or known to a reasonable person when exercising appropriate caution and due diligence in the access and use of the parking space.
- The undersigned party acknowledges, agrees, and understands that by signing this Form, the party expressly agrees that the Legislature and the Committee shall not be responsible for nor liable to such party, nor third-party subrogees, for any damages, liabilities, or other obligations incurred to the party or the party's property arising out of the access and/or use of the assigned parking space or any other parking space. This includes any vehicle being driven or used by the party, or any vehicle that is authorized by the party, to access and/or use an assigned parking space, or any other parking space under the authority and control of the Legislature and the Committee.
- The undersigned party acknowledges, agrees, and understands that by signing this Form, the undersigned party expressly waives and releases the Legislature and the Committee from any and all damages, liabilities, or other costs or obligations incurred to party or the party's property arising out of the access and/or use of the assigned parking space or any other parking space, and agrees to indemnify and hold harmless the Legislature and the Committee for the same. This includes any vehicle being driven or used by the party, or any vehicle that is authorized by the party, to access and/or use an assigned parking space, or any other parking space under the authority and control of the Legislature and the Committee.
